

# LAW NUMBER: 1-25 LAW TITLE: RECOGNIZING UNITED NATIONS' WORLD TOILET DAY AS INTERMICRONATIONAL HOLIDAY

# **LEGISLATION:**

**ARTICLE 1 - PURPOSE**. This law establishes a task force to promote the importance of sanitation and hygiene across all member states of the Union of Progressive Micronations, aiming to improve public health, prevent disease, and raise awareness of proper and essential sanitation and hygiene practices.

#### **ARTICLE 2 - DEFINITIONS.**

- 1. Sanitation and Hygiene Taskforce: A group of individuals tasked with promoting education, advocacy, and infrastructure improvement efforts related to sanitation and hygiene.
- 2. World Toilet Day: An official United Nations international observance day on November 19th to highlight the global sanitation crisis and promote action.
- 3. Member States: All micronations that are part of the Union of Progressive Micronations.
- 4. Proposal #8: A proposal submitted to the General Assembly advocating for the creation of a task force that would promote the importance of sanitation and hygiene.

## **ARTICLE 3 - ESTABLISHMENT OF THE SANITATION AND HYGIENE TASKFORCE.**

- 1. The Union of Progressive Micronations, as voted for and approved by the General Assembly under Proposal #8, shall establish the Sanitation and Hygiene Taskforce within 12 months of this law's enactment.
- 2. Each member state is encouraged to appoint a representative to participate in the task force.
- 3. The task force shall be responsible for:
  - 1. Launching awareness campaigns on sanitation and hygiene.

2. Advocating for access to clean drinking water, toilets, showers, and other sanitation infrastructure.

3. Collaborating with member states to share best practices and resources to improve sanitation systems.

**ARTICLE 4 - RECOGNITION OF WORLD TOILET DAY.** World Toilet Day, observed on November 19th, is hereby recognized as an intermicronational holiday by the Union of Progressive Micronations.

## **ARTICLE 5 - IMPLEMENTATION.**

- 1. Member states shall take reasonable steps to implement and support the initiatives of the task force.
- 2. The task force shall report to the General Assembly on progress and outcomes related to sanitation and hygiene initiatives annually, as well as when requested by authorized entities, including the General Assembly, Supreme Court, or Chairperson.

**ARTICLE 6 - ENFORCEMENT.** Each member state shall implement reasonable measures to ensure compliance with LAW 1-25.
